### A. About HELVETAS/SIPPO

HELVETAS is a co-implementing partner with SwissContact to implement the Swiss Import and Export Program. Out of the 11 countries globally, the component in Vietnam will enhance the performance of associations, trade promotion offices and trade promotion management agencies (which are considered as BSOs) in Vietnam in order to enable them to provide export promotion services in two main sectors of Technical Wood (TW) and Outdoor Furniture and Value Added Textiles (VAT) in an effective, efficient and sustainable way. 1st phase of 2016-2021 is approaching the last few months to transit into the new phase.

# **Project Objectives**

Our overall goal is to strengthen the BSO's organisational performance and the collaboration between the BSOs, that they will be able to provide professional export promotion services independently from SIPPO in the future. To realize our goal, we want to improve our facilitation activities for the existing BSOs.

# **Project Approach**

For the development of our understanding, we take two major steps:

- Research 1: We interview exporting businesses and ask them about BSOs from which they receive support.
- Research 2: We share a survey with all the identified BSOs to learn more about their organizations as well as their interaction with other BSOs.

The results from these steps are analyzed with a Social Network Analysis (SNA), which is a tool that helps to show the status of an existing network between people and organizations.
